1. Aims

This policy aims to ensure that:

- Suitable education is arranged for pupils on roll who cannot attend school due to health needs
- Pupils, staff and parents understand what the school is responsible for when this education is being provided by the local authority

2. Legislation and guidance

This policy reflects the requirements of the [Education Act 1996](#).

It also based on guidance provided by our local authority

3. The responsibilities of the school

3.1 If the school makes arrangements

Initially, the school will attempt to make arrangements to deliver suitable education for children with health needs who cannot attend school.

The Inclusion Manager/ Senco has the overview for making arrangements for any student who isn't able to attend school due to having a medical condition.

If student can't be in school, work will either be sent home or set on Google Classroom (depending on circumstances of the child. If possible and appropriate, opportunities may be made for the student to join the class online for certain lessons or celebrations such as assembly. If the child is in hospital for an extended period, liaison will be made with the hospital school in order to provide support for learning.

A meeting either physical or virtual will be held with the parent and child to discuss the protocols and expectations for schooling whilst not in school.

An individual health care plan will be written and shared with the family. A risk assessment will be written and a time table created in order to support the student back into school.

3.2 If the local authority makes arrangements

If the school can't make suitable arrangements, Kent County Council will become responsible for arranging suitable education for these children.

In cases where the local authority makes arrangements, the school will:

- Work constructively with the local authority, providers, relevant agencies and parents to ensure the best outcomes for the pupil
 - Share information with the local authority and relevant health services as required
-

- Help make sure that the provision offered to the pupil is as effective as possible and that the child can be reintegrated back into school successfully
- When reintegration is anticipated, work with the local authority to:
 - Plan for consistent provision during and after the period of education outside the school, allowing the pupil to access the same curriculum and materials that they would have used in school as far as possible
 - Enable the pupil to stay in touch with school life (e.g. through newsletters, emails, invitations to school events or internet links to lessons from their school)
 - Create individually tailored reintegration plans for each child returning to school
 - Consider whether any reasonable adjustments need to be made

4. Monitoring arrangements

This policy will be reviewed annually by a member of the SLT. At every review, it will be approved by the full governing board.
